

Terms and Conditions

Class Attendance Policy

Students are entitled to attend unlimited classes with their monthly membership.

If you sign up for a class that becomes completely full and do not show up and do not provide notice by the start of class, you will be charged a \$15 no show fee.

You can cancel a class at any time using this form or calling/emailing the studio. You have until the start of class to cancel without being charged.

If you show up to a class that is full and do not sign up, you will be charged a \$15 overcrowded fee.
